The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") respectfully moves for an order amending Decision No. 71690 (May 3, 2010) *nunc pro tunc* to correct several clerical errors.

Graham County Utilities submitted certain tariffs as compliance items as was required by the Decision. In Staff's review of the filing, Staff noted that the tariff included a rate for the 1½ inch meter. The Decision, at page 27, lines 26-27, inadvertently omits the rate for the 1½ inch meter.

On page 28, line 10, there is a mathematical error regarding the total for the service line and meter installation charges; the total should be \$560.00. Also on page 28, at line 18, for "Deposit", it should reference footnote (a).
