PROCEDURAL ORDER

**BY THE COMMISSION:**

On May 2, 2008, Arizona-American Water Company ("Arizona-American") filed an application for a rate increase and on June 20, 2008, filed the above-captioned Revised Application.

On December 8, 2009, the Arizona Corporation Commission ("Commission") issued Decision No. 71410, approving new rates and charges for the affected districts.

On June 7, 2010, Mashie, LLC (Mashie), an Arizona limited liability company doing business as Corte Bella Golf Club ("Corte Bella") filed in this docket an A.R.S. § 40-252 Application to Amend the Agua Fria District Non-Potable Water Rate Set by Decision No. 71410 or, in the Alternative, a Motion for Order Amending Decision No. 71410 Nunc Pro Tunc, Expedited Treatment Requested ("Application").

1 On June 10, 2010, at an Open Meeting of the Commission, following proper notice to all  
2 parties to Decision No. 71410,<sup>1</sup> the Commission voted to amend the Agua Fria Water District Non-  
3 Potable Water Rate set by Decision No. 71410 to \$1.24 per thousand gallons under A.R.S. § 40-252,  
4 effective immediately, with the change to be applied prospectively, and with no provision for the  
5 collection in other rates and charges of any resulting revenue shortfall. The Commission ordered the  
6 Commission's Hearing Division to issue a procedural order memorializing the Commission's  
7 determination.

8 IT IS THEREFORE ORDERED that on June 10, 2010, Decision No. 71410 was amended  
9 pursuant to A.R.S. § 40-252, to amend the Agua Fria Water District Non-Potable Water Rate set by  
10 Decision No. 71410 to \$1.24 per thousand gallons, with the change to be applied prospectively, and  
11 with no provision for the collection in other rates and charges of any resulting revenue shortfall.

12 IT IS FURTHER ORDERED that Arizona-American Water Company shall file within 30  
13 days, with the Commission's Docket Control Center as a compliance item in this matter, a tariff for  
14 its Agua Fria Water District with the new Non-Potable Water Rate of \$1.24 per thousand gallons.
