**PROCEDURAL ORDER**  
**(SCHEDULES A**  
**PRE-HEARING CONFERENCE)**

BY THE COMMISSION:

On July 9, 2010, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of Opportunity for Hearing ("Notice") against LaMel G. Young, aka Mel Young, individually and doing business as Powerball Records and Entertainment and Jane Doe Young (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock and/or investment contracts.

The Respondents were duly served with a copy of the Notice.

On July 20, 2010, a request for hearing was filed by Respondent LaMel Young.


Accordingly, a pre-hearing conference should be scheduled. Respondent may retain counsel or he may represent himself pursuant to the Commission's Rules of Practice and Procedure A.A.C. R14-3-101 *et seq.* and the Rules of the Arizona Supreme Court.

IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **August 12, 2010, at 9:30 a.m.**, at the Commission's offices, 1200 West Washington Street, Room 100, Phoenix, Arizona.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 – Unauthorized Communications) applies to this proceeding as the matter is now set for public hearing.
