PROCEDURAL ORDER

BY THE COMMISSION:

On April 29, 2010, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application in Docket No. E-01345A-10-0166, pursuant to the requirements of Decision No. 71448 (December 30, 2009), for approval of a new program for on-site solar energy for schools and governmental institutions that the Company claims would substantially reduce or eliminate upfront customer cost for solar energy ("Schools and Government Program").

On July 1, 2010, APS filed an application in Docket No. E-01345A-10-0262 for approval of the Company's 2011 Renewable Energy Standard Implementation Plan ("2011 Plan") and Distributed Energy Administration Plan.

On July 15, 2010, APS filed Motions to Consolidate the above-captioned dockets. APS states that the Schools and Government Program is relevant to the 2011 Plan and that consolidation of these matters will assist the Commission in its consideration of both.

No objections to the consolidation request have been filed.

IT IS THEREFORE ORDERED that Docket Nos. E-01345A-10-0166 and E-01345A-10-

1 **0262 are hereby consolidated.**

2 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
3 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
4 hearing.
