
8 Global Water – Palo Verde Utilities Company, Global Water – Santa Cruz Water
9 Company, Valencia Water Company – Town Division, Valencia Water Company – Greater
10 Buckeye Division, Water Utility of Greater Tonopah and Willow Valley Water Co. (collectively,
11 the “Global Utilities”) respectfully respond to Staff’s “Request for Clarification of the
12 Recommended Opinion and Order and Procedural Conference” (the “Request”). The Global
13 Utilities support the request.

14 In addition, the Global Utilities note that they have been unable to validate the proof of
15 revenue for Water Utility of Greater Tonopah (“WUGT”), that is, the proposed rates for WUGT in
16 the Recommended Opinion and Order (ROO) do not appear to generate the revenue requirement
17 the ROO adopts for WUGT. The Global Utilities suggest that this issue be addressed in any
18 procedural conference or Hearing Division filing made in response to the Request.

19 In addition, the Global Utilities request that the Hearing Division make available to the
20 parties the schedules (in electronic format) used by the Hearing Division or its Advisory Team in
21 preparing the ROO. Access to the schedules will assist the parties in evaluating technical issues
22 concerning the ROO, such as those raised by Staff and the Global Utilities.
