JOINT STATUS REPORT


1 On June 16, 2010, a settlement conference among the Parties to this proceeding was
2 convened at the offices of the Commission. The Parties participating in that settlement
3 conference were TracFone Wireless, Inc. ("TracFone"), petitioner for designation as an Eligible
4 Telecommunications Carrier ("ETC"), the Arizona Local Exchange Carriers Association
5 ("ALECA"), and Commission Staff ("Staff"). The purpose for that settlement conference was to
6 afford the Parties an opportunity to discuss issues regarding TracFone's petition for designation
7 as an ETC and to attempt to find resolutions to issues upon which the Parties may disagree.

8 By Procedural Order issued by Administrative Law Judge, Yvette B. Kinsey, June 25,
9 2010, the status conference scheduled for July 1, 2010, at 10:00 a.m. was vacated, and the Parties
10 were directed to make a joint filing within 30 days of the Procedural Order updating the
11 Commission on the resolution of any disputed issues and/or requesting the scheduling of a status
12 conference.

13 In this report, the Parties apprise the Administrative Law Judge and the Commission that
14 the Parties have significantly narrowed the issues to be resolved and are optimistic that the
15 remaining issues may be narrowed further, if not resolved altogether, if they can be provided
16 some additional time. To that end, the Parties request an additional 21 days to continue their
17 discussions. The Parties propose to file an additional status report by August 16, 2010.

18 The undersigned attorney has conferred with Staff's and TracFone's attorneys and has
19 been authorized to file this pleading on their behalf, as well as for ALECA.


