
(Expedited Request)

NextGen Communications, Inc. ("NextGen") hereby files its Motion to Extend Time to publish notice of NextGen's Application For Approval Of A Certificate Of Convenience And Necessity To Provide Private Line And Access Telecommunications Services. By Procedural Order dated July 19, 2010, NextGen was ordered to publish the notice in a newspaper of general circulation in every county in Arizona in which NextGen desires to provide service by August 2, 2010. NextGen desires state-wide service and this requires that there be notices placed in newspapers covering every county in Arizona. To secure such notice requires the use of daily and weekly publications, and is a more complex process than NextGen can arrange before the prescribed deadline. Therefore, NextGen requests a 60-day extension of the original notice deadline. In light of this Motion for Extension, NextGen requests that the

1 Commission also reset the other associated deadlines and NextGen's hearing date as
2 required by the granting of this request. Lastly, NextGen respectfully requests
3 expedited treatment of this Motion.
