PROCEDURAL ORDER

BY THE COMMISSION:

On December 21, 2009, Casa Grande West Water Company, Inc. ("Applicant") filed with the Arizona Corporation Commission ("Commission") applications for financing and a rate increase.

On May 20, 2010, the Commission's Utilities Division ("Staff") filed a Letter of Sufficiency classifying Applicant as a Class D Utility, indicating that the rate application was sufficient, indicating that a Commission Decision should be rendered on or about November 16, 2010, and indicating that Staff would file a Staff Report on or about August 3, 2010.

On June 1, 2010, by Procedural Order, the applications were consolidated.

On July 23, 2010, Staff filed a Request for an Extension of Time to File Staff Report ("Request"). The Request stated that Applicant's responses to data requests have been slow, and that the responses do not always completely or adequately respond to Staff's requests. Staff stated that due to the extra time the discovery process is taking, Staff requires an additional three weeks to insure that Staff has all the information and time required to appropriately and fairly analyze the applications, and to complete its Staff Report.

Applicant filed no response to Staff's Request.


Staff's request is reasonable under the circumstances. Adequate time should be allowed for Staff to collect from Applicant, and subsequently analyze, the information required to complete its Staff Report. Good cause is therefore shown to extend the deadline for the filing of the Staff Report,

1 and to accordingly extend the timeclock in this matter pursuant to R14-2-103(B)(11)(e).

2 IT IS THEREFORE ORDERED that the deadline for filing the Staff Report is hereby
3 extended until August 24, 2010.

4 IT IS FURTHER ORDERED that pursuant to R14-2-103(B)(11)(e), the timeclock is
5 accordingly extended by 21 days.
