 17 *Concrete Crossing Panels, and Install 2 Flasher/Gate Combo Units at Again Bridge Crossing;* RR-
 18 02634A-10-0237, *In the Matter of the Application of Arizona Eastern Railway Company for*
 19 *Approval to Install Gates, Flashing Lights and a Crossing Surface on Bixby Road;* RR-02634A-10-
 20 0236, *In the Matter of the Application of Arizona Eastern Railway Company for Approval to Install*
 21 *Gates and Flashing Lights on College Avenue;* RR-02634A-10-0235, *In the Matter of the Application*
 22 *of Arizona Eastern Railway Company for Approval to Install Gates, Flashing Lights and a Crossing*
 23 *Surface on Central Road.* Staff is filing separate motions in each of these dockets requesting this
 24 consolidation.

25 The issues involved in these matters are substantially related and consolidation will not
 26 prejudice the rights of the parties. Staff believes that consolidation of these matters will aid the
 27 Commission in its evaluation of these matters.
