 16 *of the Application of Arizona Eastern Railway Company for Approval to Install Gates, Flashing*
 17 *Lights and a Crossing Surface on Bixby Road*; RR-02634A-10-0238, *In the Matter of the Application*
 18 *of Arizona Eastern Railway Company for Approval to Replace Existing Crossing with Concrete*
 19 *Crossing Panels, and Install 2 Flasher/Gate Combo Units at Again Bridge Crossing*; RR-02634A-
 20 10-0239, *In the Matter of the Application of Arizona Eastern Railway Company for Approval to*
 21 *Replace an Existing Crossing with Concrete Crossing Panels, and Install 2 Flasher/Gate Combo*
 22 *Units at Sam's Crossing*. Staff is filing separate motions in each of these dockets requesting this
 23 consolidation.

 26 Commission in its evaluation of these matters.


