
**LEGAL DIVISION STAFF'S REQUEST
FOR AN EXTENSION OF THE BRIEFING
SCHEDULE**

The Arizona Corporation Commission ("ACC" or "Commission") Legal Division ("Staff") respectfully requests an additional two-week extension of time to file Initial Briefs in this matter. In addition, if Staff's request for a two-week extension of time to file Initial Briefs is granted, other parties to this Docket would like the deadline for Reply Briefs to be extended by two weeks as well.

Initial Briefs in this matter are currently due on Friday, June 25, 2010; and Reply Briefs are due on August 13, 2010. Due to a court imposed deadline and Staff's heavy workload at this time, Staff needs additional time to go through the voluminous record in this case and write its brief. Staff believes that it should be able to accomplish this with an additional two weeks time. Staff has emailed the attorneys for the other parties in this docket. No party opposes Staff's request, however, several parties specifically request that if Staff's request for an extension of the deadline for Initial Briefs is granted, that the deadline for Reply Briefs be extended by a like period. Staff does not oppose an extension of the deadline for Reply Briefs as well. If Staff's request is granted, Staff has calculated the new deadline for Initial Briefs to be July 9, 2010; and the new deadline for Reply Briefs to be August 27, 2010.
