**NOTICE OF FILING STAFF'S
CLARIFICATION**

On June 9, 2010, Arizona Corporation Commission ("Commission") Legal Division Staff ("Staff") forwarded the Commission's rulemaking materials approved by Decision No. 71722 (June 3, 2010) to the Attorney General for approval. On June 11, 2010, documents were docketed in this matter that had been provided from the Attorney General's office. One of the documents included a page for the Attorney General's signature to indicate approval of final rules that had been signed. A second document was a copy of the original proposed rules. Due to confusion related to the docketing of these documents, Staff provides the following clarification.

Upon inquiry to the assigned Assistant Attorney General processing this matter, Staff is informed that the Commission's rulemaking has not been approved yet and the rules package is still being processed at the Attorney General's office. Further, it was explained that returning the signed Attorney General Approval of Final Rules page had been intended solely as an indication that the rulemaking documents had been received and was not meant to indicate approval of the rulemaking.

With respect to the copy of the original proposed rules that was docketed the same day, the date stamp on the front page indicates that it is a copy of the proposed rules that had been provided to the Secretary of State in December of 2009. Staff would clarify that the rules that were forwarded to
