PROCEDURAL ORDER

BY THE COMMISSION:

The hearings on the stranded cost and unbundled and standard offer service tariffs of Mohave Electric Cooperative, Inc. ("Mohave"), Trico Electric Cooperative, Inc. ("Trico"), Graham County

1 Electric Cooperative, Inc. ("GCEC"), Duncan Valley Electric Cooperative, Inc. ("Duncan") have
2 been consolidated and are currently scheduled for November 18, 1999.


3 On November 9, 1999, Mohave filed a motion to continue the hearing in Docket Nos. RE-
4 0000C-94-0165, E-01787A-98-0465, and E-01750A-97-0701 on the grounds that Mohave cannot
5 develop its stranded cost recovery plan until after Arizona Electric Power Cooperative, Inc.'s
6 ("AEPCO") stranded cost proceeding is completed. On November 10, 1999, Trico filed a Motion to
7 continue the hearing in Docket Nos. RE-00000C-94-0165, E-01461A-98-0466 and E-01461A-97-
8 0696 on the same grounds.

9 The Affected Utilities designated above are all members of AEPCO and face the same issue
10 concerning the flow through of AEPCO's stranded costs. It is in the public interest that the stranded
11 cost and unbundled and standard offer tariff hearings in the above captioned matters be continued
12 until after the Commission has made a determination concerning AEPCO's stranded costs and
13 tariffs.

14 IT IS THEREFORE ORDERED that the hearing currently scheduled for November 18, 1999,
15 is hereby continued until **February 7, 2000**, at 10:00 a.m. at the Commission's offices in Phoenix
16 Arizona.

17 IT IS FURTHER ORDERED that a pre-hearing conference shall be held on January 31, 2000,
18 at 1:30 p.m. at the Commission's offices in Tucson, Arizona, except that any party wishing to appear
19 telephonically shall contact the Hearing Officer prior to the date of the pre-hearing conference.


