COOPERATIVES' STRANDED COST HEARING**



For the reasons set forth in Duncan and Graham's response and Trico Electric Cooperative, Inc.'s response, SSVEC requests that the Application be denied until various other issues concerning the Electric Competition Rules have been resolved.
