13 BY THE COMMISSION:

14 A hearing in this matter was held on March 16, 2010. At the close of the hearing, the parties  
15 agreed to a briefing schedule that had Initial Briefs due May 21, 2010, and Reply Briefs due on June  
16 25, 2010. By Procedural Order dated May 18, 2010, the briefing schedule was modified such that


