However, it may not be necessary to continue these matters to a date after the Commission has entered a final order on the AEPCO transition revenues/regulatory assets case. Instead, it may only be necessary to continue this hearing until after the AEPCO hearing has been conducted.

For this reason, Duncan and Graham suggest the November 18 hearing be continued and a status conference be scheduled at a date and time convenient to the Hearing Officer after the AEPCO hearing has been concluded. The parties then could discuss scheduling and remaining issues.
