
Intervention in the Commis-

matter. Persons desiring to in-  
tervene must file a Motion to  
intervene with the Commis-  
sion which must be served  
upon applicant and which, at a  
minimum, shall contain the  
following information: (1) the  
name, address and telephone  
number of the proposed  
intervenor and of any person  
upon whom service of docu-  
ments is to be made if differ-  
ent than the intervenor; (2) A  
short statement of the pro-  
posed intervenor's interest in  
the proceeding; (3) Whether  
the proposed intervenor de-  
sires a formal evidentiary  
hearing on the application and  
the reasons for such a hear-  
ing; (4) A statement certifying  
that a copy of the Motion to  
intervene has been mailed to  
Applicant. The granting of Mo-  
tions to Intervene shall be  
governed by A.A.C. R14-3-106,  
except that all Motion to inter-  
vene must be filed on, or be-  
fore, the 15th day after this  
notice.


