PROCEDURAL ORDER

BY THE COMMISSION:

6 The hearings on the stranded cost and unbundled and standard offer service tariffs of Mohave
7 Electric Cooperative, Inc. ("Mohave"), Trico Electric Cooperative, Inc. ("Trico"), Graham County
8 Electric Cooperative, Inc. ("GCEC"), Duncan Valley Electric Cooperative, Inc. ("Duncan"), and
9 Sulphur Springs Valley Electric Cooperative, Inc. ("Sulphur Springs") have been consolidated and
10 are currently scheduled for February 7, 2000.

11 On January 14, 2000, Mohave filed a motion to continue the hearing in Docket Nos. RE-
12 0000C-94-0165, E-01787A-98-0465, and E-01750A-97-0701 on the grounds that Mohave cannot
13 develop its stranded cost recovery plan until after Arizona Electric Power Cooperative, Inc.'s
14 ("AEPCO") stranded cost proceeding is completed. The hearing on AEPCO's stranded costs is
15 currently scheduled to commence on February 28, 2000. None of the Affected Utilities named
16 above, nor Commission Staff have opposed, nor have they responded to, Mohave's motion to
17 continue the February 7, 2000 hearing.

18 The Affected Utilities designated above are all members of AEPCO and face the same issue
19 concerning the flow through of AEPCO's stranded costs. A number of them supported a previous
20 motion to continue the hearing that was based on the same reasoning. It is in the public interest that
21 the stranded cost and unbundled and standard offer tariff hearings in the above captioned matters be
22 continued until after the Commission has made a determination concerning AEPCO's stranded costs
23 and tariffs.




