

MOTION TO INTERVENE

COMES NOW THE CITY OF BULLHEAD CITY, ARIZONA, a municipal corporation, (the "City"), by and through its Attorney, Loretta Humphrey, pursuant to the Commission Rules of Practice and Procedure, R14-3-105. The City hereby moves the Commission for leave to intervene in the above-captioned and docketed matter relating to the applications of various electric co-operatives for unbundled and standard offer service tariffs. Of particular interest and concern to the City is the application of the Mohave Electric Cooperative, Inc. In her Procedural Order dated January 21, 2000 this Commission's Hearing Officer vacated the scheduled pre-hearing conference and the hearing on this matter until the resolution of AEPCO's stranded costs

and unbundled tariffs. It is the understanding of the City that the AEPCO matter may be settled soon. At that time it will be necessary to reschedule consideration of the involved and interested co-operatives' requests. The City makes the within motion for the following reasons:

1. The City is a customer of the Mohave Electric Coop and purchases from it a substantial amount of electrical energy vital to the conduct of the City's municipal functions;
2. The revised rate schedules on which the Commission will be asked to rule may have a significant impact on the amounts paid by the City and its citizens for electrical services;
3. The intervention of the City will not expand or in any way change the scope of the hearings to be scheduled or the issues requiring consideration in this matter;
