12 Pursuant to A.A.C. R14-3-105, the Arizona Electric Power Cooperative, Inc. ("AEPCO")
13 submits this Application to Intervene in these consolidated cases. Each of the distribution
14 cooperatives involved in these consolidated cases is a Class A member of AEPCO. An issue
15 common to each proceeding is the flow through of the stranded cost CTC and RAC charges
16 authorized for AEPCO by the Commission in Decision No. 62758.

17 AEPCO's interests in the application and collection of its authorized stranded cost
18 charges may be directly and substantially affected by these proceedings. Further, in Decision
19 No. 62758, the Commission deferred to the Mohave stranded cost case North Star related CTC
20 and RAC issues and AEPCO's participation is necessary to fully develop those matters. Finally,
21 AEPCO's intervention will not unduly broaden the issues involved in these consolidated cases.
