15 Pursuant to the procedural order issued July 10, 2002 in this matter, we provide the  
16 following joint status report concerning the status of settlement discussions. The parties  
17 are engaged in settlement communications. Those efforts have accelerated in the past few  
18 days, and are ongoing. Although no agreement has been reached, there is reason for  
19 optimism as the parties have reached agreement on some terms and are narrowing the gap  
20 on others. The parties agree to extend the date by which the University will file its  
21 Amended Petition to July 23, 2002, at which time more information will be known  
22 regarding the prospects for settlement.


