NOTICE OF CLOSURE

AT&T Inc. ("AT&T") and Verizon Wireless, pursuant to ordering paragraph 3 of the Commission's Decision No. 71260 ("Decision"), provide notice that the transfer of certain wireless assets from Verizon Wireless to AT&T has closed. In the Decision, the Commission approved the transfer of certain wireless assets in Gila and Pinal Counties from Verizon Wireless to AT&T.

Ordering paragraph 3 of the Decision (at p. 12) required that the Commission be notified "within 30 days following the closure of the transfer of assets proposed in this application." On June 22, 2010, the FCC approved AT&T's acquisition of the assets from Verizon Wireless and the purchase transaction closed on the same day.
