**6. Alternative Operator Services/Surcharges**

In addition to the charges shown in 5., an Operator Dialed Surcharge applies to Operator Station and Person-to-Person calls when the Customer has the capability of dialing all the digits necessary to complete a call, but elects to dial the appropriate operator code and requires prompting by the operator system to dial the called station or requests the operator to dial the called station.

The surcharge does not apply to:

- Calls where a Customer cannot otherwise dial the call, due to defective equipment or trouble on the Company's network.
- Calls in which a Company operator places a call for a calling party who identifies himself/herself as being a Customer with disabilities and is unable to dial the call because of such disability.
- Calling Card calls.
