AMEND THE CAPTION

The Securities Division of the Arizona Corporation Commission ("Division") hereby requests that the caption of the original Temporary Order to Cease and Desist and Notice of Opportunity for Hearing ("TC&D") filed in this action be amended. The Division's motion to amend the caption seeks to remove Deseree T. Mitchell ("D. Mitchell") from the caption and revise it as James Mitchell, an unmarried individual. No changes are requested for La Bella Investments, LLC.

At the time of filing, based on the Division's information and belief, D. Mitchell was included solely for the purposes for determining the liability of the marital community pursuant to A.R.S. § 44-2031(C). However, the Division has confirmed that James Mitchell and D. Mitchell were divorced on December 4, 2009, by decree of divorce, CV-DR-2009-06007, entered in the state of Idaho. The Divorce of Mitchell and D. Mitchell occurred prior to the securities violations alleged in the TC&D.


