Decision No. 70658 requires Wilhoit Water Company report monthly revenue from its standpipe service on a quarterly basis.

However, the Company inadvertently failed to report one additional deposit during the second quarter. On June 22, 2010 the Company deposited \$2,000 for a total of \$7,000 deposited during this reporting period.
