

PROCEDURAL ORDER

12 **BY THE COMMISSION:**

13 On May 26, 2010, the Securities Division ("Division") of the Arizona Corporation
14 Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of
15 Opportunity for Hearing ("Notice") against La Bella Investments, LLC ("LBI") and James Mitchell
16 and Deseree T. Mitchell, husband and wife.

17 On July 13, 2010, the Division filed a Motion to Amend the Caption ("Motion") in this
18 proceeding and requested that Deseree T. Mitchell be removed from the caption. The Division's
19 Motion states that James Mitchell and Deseree T. Mitchell were granted a Decree of Divorce on
20 December 4, 2009, in the state of Idaho prior to May 3, 2010, the first date of any alleged violation
21 set forth in the T.O. and Notice of this proceeding.

22 Accordingly, the Division's Motion should be granted and the caption amended.
23 Additionally, the Division should take whatever steps which are necessary to amend the T.O. and
24 Notice based on the divorce of the Mitchells.

25 IT IS THEREFORE ORDERED that the caption to the proceeding shall be amended
26 henceforth with the deletion of Deseree T. Mitchell and reflect properly James Mitchell, an
27 unmarried individual.

1 IT IS FURTHER ORDERED that Respondent, La Bella Investments, LLC, shall remain a
2 party to the proceeding.

3 IT IS FURTHER ORDERED that the Division shall take whatever steps which are necessary
4 to amend the T.O. and Notice based on the divorce of the Mitchells as disclosed in the Motion to
5 Amend the Caption.
