
This letter is in response to your correspondence of September 12, 2002⁷ which was not received at our offices until yesterday, September 25, 2002. As we discussed during our telephone conversation of yesterday, the letter was apparently delayed due to an incorrect address.

The purpose of this letter is to clarify that the owners of Bowie Power Station, L.L.C. have not made a final decision to design and construct the project as a Qualifying Facility ("QF") under PURPA. That is a course of action that has been under consideration during the past few months, and they wanted to advise the Commission's Staff of that possibility, but the analysis is still under way. In the event a decision of that nature is reached, or a decision as to another type of plant design, the project owners will submit a written request for review of the type described in your letter. In the interim, it should be assumed that the facility will be designed and constructed as authorized in Decision Nos. 64625 and 64626.
