Dear Ms. Woodall:

During Arizona Public Service Company's (the "Company") November 2002 proceedings to secure a Certificate of Environmental Compatibility for its North Valley Project, you requested that the Company provide the Siting Committee with copies of cultural surveys conducted for the project route. In an effort to address the Committee's concerns, the Company is providing you with copies of site-specific cultural resources surveys that were conducted for the above project. These surveys include the following:

- Cultural Resources Survey at Interstate 17 and Happy Valley Road Between Mileposts 217.66 and 218.37, Phoenix, Maricopa County;
- Cultural Resource Survey for a City of Phoenix Water Line Along Interstate 17, Maricopa County, Arizona (draft);
- A Cultural Resources Survey of the Interstate-17 Highway Corridor from the New River Traffic Interchange (Milepost 232.0) to Milepost 245.01 Located Just North of the Black Canyon Traffic Interchange, Maricopa and Yavapai Counties, Arizona.

However, given that the above surveys contain sensitive site-specific information that is not generally circulated for public consumption, the Company is only providing you, as Chair of the Committee, with a copy of the surveys. In addition, the Company will file this letter with docket and send copies to all parties to the above proceedings, indicating that it has met the
