

This letter is in follow up to our conversation this past Monday morning, and your conversation with Jim Sweeney (with my permission) to discuss a limited tour of the Beardsley Canal.

The Maricopa Water District remains adamantly opposed to any consideration of the Beardsley Canal as the site for placement of the transmission line. However, the District will accommodate the limited tour of the Canal that you proposed to Mr. Sweeney this week, which I understand to be a short jaunt in vehicle or on foot approximately one-quarter mile north of Olive so that Committee members can see the substation site. You have my continuing permission to talk to Mr. Sweeney directly regarding the specifics of this tour.
