
**MOTION TO CONTINUE

Mohave Electric Cooperative, Inc. ("Mohave") has filed a Motion to Continue Hearing Date with the Hearing Division to continue the hearing in Docket Nos. RE-00000C-94-0165, E-01787A-98-0465 and E-01750A-97-0701 from November 18, 1999, to a date after the stranded cost proceeding of Arizona Electric Power Cooperative, Inc. ("AEPSCO") is completed and a final

1 order regarding AEPCO's stranded cost methodology is issued by the Commission. Trico Electric
2 Cooperative, Inc. ("Trico") joins in Mohave's Motion for the same reasons that Mohave has set
3 forth in its motion. This Motion is supported by the attached Memorandum of Points and

17 Memorandum are applicable to Trico.


18 Trico, like Mohave, is a distribution cooperative and a Class A Member of AEPCO. The
19 same argument made by Mohave supporting its Motion is applicable to Trico and Trico adopts
20 Mohave's Memorandum.

21 WHEREFORE, Trico respectfully requests that Trico's stranded cost, unbundled tariff and
22 standard offer tariff hearings be continued from November 18, 1999, to a date after AEPCO's
23 stranded cost proceeding is completed and a final order regarding AEPCO's stranded cost
