**PROCEDURAL ORDER**

**BY THE COMMISSION:**

On February 9, 2010, Gary R. Bahr and Larry C. Rowley ("Complainants") filed with the Arizona Corporation Commission ("Commission") a Complaint ("Complaint") against Qwest Corporation ("Respondent").

On March 2, 2010, the Respondent filed its Motion to Dismiss the Complaint.

On June 9, 2010, a Procedural Order was filed setting oral argument in the Respondent's Motion to Dismiss for July 1, 2010.<sup>1</sup>

The matter convened at the date and time set, but the Complainants did not appear. As such, oral argument will be rescheduled. The date and time for oral argument will be determined at a Procedural Conference as noticed below.

In the interest of administrative efficiency, the Procedural Conference in this matter will be held concurrently with the procedural conferences set in Docket Nos. E-01461A-10-0073, T-20449A-10-0081, and W-03293A-10-0273.

<sup>1</sup> The Procedural Conference had been originally scheduled for June 29, 2010, but was changed to July 1, 2010, due to a scheduling conflict.

1 IT IS THEREFORE ORDERED that a **telephonic procedural conference for the purpose**  
2 **of rescheduling the oral arguments for the Respondent's Motion to Dismiss** shall be held on  
3 **September 17, 2010, at 10:00 a.m.**, or as soon thereafter as is practicable, and that all parties shall  
4 contact the Hearing Division on **September 10, 2010, at 602-542-4250 for further information**  
5 **regarding the call-in phone number.** Parties may also attend in person at the Commission's Tucson  
6 offices, Room 218, 400 West Congress.

7 IT IS FURTHER ORDERED that **the Complainants may file a Reply to the request to**  
8 **dismiss in this matter if the Complainants wish to do so.** If the Complainants choose to file a  
9 Reply, such Reply must be filed with the Commission's Docket Control, 1200 West Washington  
10 Street, Phoenix, Arizona, 85007-2927, including the original and 13 copies, and an additional copy  
11 must be forwarded to the Respondent.

12 IT IS FURTHER ORDERED that the Procedural Conference in this matter will be held  
13 concurrently with the Procedural Conference scheduled in Docket Nos. E-01461A-10-0073, T-  
14 20449A-10-0081 and W-03293A-10-0273. In addition to rescheduling oral arguments, the parties  
15 should be prepared to discuss the possible consolidation of all dockets.

16 IT IS FURTHER ORDERED that **if the Complainants fail to appear at this Procedural**  
17 **Conference without just cause, the Complaint shall be dismissed.**

18 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules  
19 of the Arizona Supreme Court and A.R.S. §40-243 with respect to practice of law and admission *pro*  
20 *hac vice.*
