PROCEDURAL ORDER

BY THE COMMISSION:


On July 15, 2010, Tri-M Communications, Inc. dba TRM Communications ("TMC"), in conjunction with Michelle Cutlip ("MC"), Michael E. Pfau, Trustee of the Meslissa Marsch-Baker Trust U/D/T ("Trust"), and 5LINX Enterprises, Inc ("5LINX") (collectively the "Parties") filed a notification with the Arizona Corporation Commission ("Commission") of a transaction that would result in a change of control of ownership of TMC. The notification stated that the Parties are in the process of completing a transaction where 5LINX will acquire 100 percent of TMC's stockholder shares and will result in a change in control of TMC. The notification states that the proposed transaction will not result in any change in telecommunication services provided by TMC or its rates or terms and conditions of service.

On August 4, 2010, the Commission's Utilities Division ("Staff") filed a Memorandum recommending administrative closure of this docket. Staff states that TMC is not a Class A utility pursuant to Arizona Administrative Code R12-2-801 to R12-2-806 and therefore is not required to obtain prior approval for the transfer of control transaction. Therefore, Staff requests administrative closure of the above referenced docket.

Based on the information provided by the Parties and Staff, administrative closure of the above referenced docket is reasonable.


