PROCEDURAL ORDER
(Vacates a Hearing)

BY THE COMMISSION:

On April 20, 2010, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of Opportunity for Hearing ("Notice") against Global Trading Partners, LLC ("GTP"), Michael Eugene Gowens and Jane Doe Gowens, husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock or notes.

The Respondents were duly served with a copy of the Notice.

On May 10, 2010, a request for hearing was filed by Respondent Michael E. Gowens, individually and as "President" of GTP.

On May 13, 2010, by Procedural Order, a pre-hearing conference was scheduled on June 2, 2010.

On June 2, 2010, the Division and Respondents appeared with counsel. Counsel for Respondents indicated that Mr. Gowens was not married. The parties were discussing a possible settlement of the allegations contained in the T.O. and Notice, but the Division requested that a hearing be scheduled after the Securities Open meeting scheduled on August 12, 2010, in the event a settlement was not concluded.

1 On June 3, 2010, by Procedural Order, a hearing was scheduled to commence on August 18,
2 2010.

3 On August 12, 2010, the Commission approved a Consent Order with respect to all
4 Respondents in the proceeding. Subsequently, the Division filed a Motion to Vacate the hearing.

5 Accordingly, the hearing should be vacated.

6 IT IS THEREFORE ORDERED that the **hearing** scheduled to commence on **August 18,**
7 **2010, is hereby vacated.**

8 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
9 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
