PROCEDURAL ORDER

BY THE COMMISSION:

On May 14, 2010, Mike Fricker, general manager and owner of Salt River Solar & Wind, LLC ("Salt River") filed with the Arizona Corporation Commission ("Commission") a formal complaint against Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC" or Cooperative") requesting that the Commission order SSVEC to make solar incentive payments to Salt River in the amount of \$345,796.75 ("Complaint").

On June 10, 2010, SSVEC filed its Answer and requested that the Commission dismiss the Complaint.

On August 3, 2010, by Procedural Order, a procedural conference was scheduled on August 23, 2010, to address scheduling and other matters.

On August 19, 2010, Salt River filed a Request to Dismiss stating that SSVEC has taken reasonable steps to provide Salt River with assurance that they are making payment to rebate the customers in a timely manner. Salt River also requested that the procedural conference on August 23, 2010, be vacated.

On August 19, 2010, the Utilities Division ("Staff") filed its Response to the Request to Dismiss, indicating that Staff had no objection to the dismissal of the Complaint.

1 Accordingly, the Complainant's Request to Dismiss should be granted.

2 IT IS THEREFORE ORDERED that Salt River Solar & Wind's Request to Dismiss is hereby
3 granted.

4 IT IS FURTHER ORDERED that the **procedural conference** currently scheduled for **August**
5 **23, 2010**, is hereby **vacated**.

6 IT IS FURTHER ORDERED that **Docket No. E-01575A-10-0195** is hereby
7 **administratively closed**.
