MOTION TO SET HEARING

On June 3, 2010, the Securities Division and Respondents Mark W. Bosworth, Lisa A. Bosworth, Mark Bosworth & Associates, L.L.C., and 3 Gringos Mexican Investments, L.L.C. ("3GMI") (collectively "Respondents") entered into a proposed consent order. Testimony at the administrative hearing for Respondents Michael J. Sargent and Peggy L. Sargent indicated that the transfer of property contemplated by the 3GMI private party settlement had not yet occurred. As a result of that fact, and a recalculation of restitution, it was determined that the proposed consent order should not be submitted to the Commission for its consideration. Despite discussion, the Securities Division and Respondents have not been able to reach agreement on a revised proposed

1 consent order. Therefore, the Securities Division requests that the Hearing Division set for hearing
2 the matter involving these Respondents before a different Administrative Law Judge.
