**RESPONSE TO STAFF
REPORT AND AMENDMENT
TO APPLICATION**

Through this filing, TeleQuality Communications, Inc. ("TeleQuality") amends its Application in this docket by eliminating its request for facilities-based authority. TeleQuality did not intend initially to provide facilities-based service and given the prohibitive nature of the performance bond requirement for doing so, TeleQuality has determined that it will only seek resold private line authority.

As a result of this amendment, TeleQuality respectfully requests that the hearing in this matter be vacated as a hearing is not required. See ARS § 40-282.C. TeleQuality has conferred with Staff, and Staff agrees that a hearing is not necessary or required.


In addition, TeleQuality requests that the performance bond requirement be reduced to \$25,000, which is consistent with the performance bond requirement for a reseller of local exchange authority. TeleQuality notes, as did Staff in its Staff Report, that TeleQuality does not collect deposits. As a result, deposits should not be considered in setting the bond amount. TeleQuality has confirmed with Staff, and Staff has agreed that

1 this amount (i.e, \$25,000) is appropriate given the amendment to the Company's
2 application.

3 For all of these reasons, TeleQuality respectfully requests that the hearing be
4 vacated, that the Administrative Law Judge take this matter under advisement and issue a
5 Recommended Opinion and Order ("ROO") for resold authority, and that such ROO
6 include a recommendation for a performance bond in the amount of \$25,000.
