Respondent/Plaintiff Cynthia Lea White filed an action for administrative review on August 4, 2010 with the Maricopa County Superior Court as cause number LC2010-000611-001 DT pursuant to A.R.S. § 12-904(B). As such, Plaintiff provided the Arizona Corporation Commission ("ACC") with notice of the action and requested the ACC to transmit designated portions of the record on review to the Superior Court. One of the items of the record to be transmitted is an audio recording of the May 13, 2010 Open Meeting, which must be transcribed prior to the ACC sending it to the Superior Court.

On August 18, 2010, the ACC filed a motion to dismiss Plaintiff's administrative review action with Superior Court. If the Court grants the ACC's motion to dismiss, it will dispose of Plaintiff's administrative review action and the need for transcription of the May 13, 2010 Open Meeting audio recording. Counsel has conferred with Mr. Huynh of the Securities Division and he has no objection to the stay. Therefore, Respondent/Plaintiff White respectfully requests a stay of

1 the transcription of the May 13, 2010 Open Meeting audio recording pending the Court's ruling on
2 the ACC's motion to dismiss.
