PROCEDURAL ORDER

BY THE COMMISSION:

A hearing in this matter was held on March 16, 2010. By Procedural Order dated June 22, 2010, the briefing schedule was modified such that the deadline for Reply Briefs was extended until August 27, 2010.

On August 20, 2010, Cox Arizona Telcom, LLC, Eschelon Telcom of Arizona, Inc., Electric Lightwave, LLC and Mountain Telecommunications of Arizona Inc. dba Integra Telecom, McLeodUSA LLC and DIECA Communications, Inc. dba Covad Communications Company (jointly "CLECs") filed a Request for Extension of Time to File Reply Briefs. CLECs sought an extension of approximately 2 1/2 weeks.

CLECs reported that Commission Staff, and Qwest support the extension; that ALECA, Verizon and Sprint do not oppose the extension; and that counsel for CLECs did not receive a response from RUCO or AT&T. AT&T subsequently reported it had no opposition to the request.


