BY THE COMMISSION:

On August 9, 2010, Ajo Improvement Company ("AIC") filed an application for an Order from the Arizona Corporation Commission ("Commission") to approve the transfer of fourteen (14) 69 kV distribution line poles and related facilities to Arizona Public Service Company ("APS"). According to the Application, the purpose of the transfer is to facilitate the interconnection of a renewable generation project near Ajo Arizona. AIC has requested expedited consideration.

On August 20, 2010, APS filed a Motion to Intervene.

APS will be directly and substantially affected by the outcome of the Application.
