PROCEDURAL ORDER

BY THE COMMISSION:

On May 14, 2010, SOLON Corporation ("SOLON") filed with the Arizona Corporation Commission ("Commission") an application for Special Contract Approval for a Solar Services Agreement ("SSA").

On July 12, 2010, the Commission issued Decision No. 71795 which addressed a previous application by SolarCity Corporation ("SolarCity") seeking an adjudication that it was not acting as a public service corporation when it provides solar services to Arizona schools, governments, and non-profit entities by means of an SSA. In Decision No. 71795, the Commission found that when SolarCity provides services to schools, governments, or other non-profit entities pursuant to an SSA, it is not acting as a public service corporation.

On August 20, 2010, the Commission's Utilities Division ("Staff") filed a memorandum in this docket stating that the SOLON SSA includes the installation of solar facilities at a customer's premises through an SSA similar to SolarCity's SSA that was the subject of Decision No. 71795. In light of the Commission's findings in Decision No. 71795, Staff recommends that the Commission issue an order closing this docket.


