MOTION TO CONSOLIDATE

The Arizona Corporation Commission Staff ("Staff") hereby moves to consolidate Docket No. W-02355A-09-0275, Heart Cab Co., Inc. dba Sulger Water Company #2's ("Company") application for a rate increase, with Docket No. W-02355A-10-0330, Sulger Water Company #2's application for approval of financing.

On June 1, 2009 the Company filed an application for a rate increase with the Arizona Corporation Commission. Staff notified the company on August 23, 2010 that the application was sufficient. On July 28, 2010 the Company filed an application for approval of financing. On August 3, 2010 the Company filed an amendment to the financing application.

Because of the interrelated nature of the financing application in Docket No. W-02355A-10-0330 and the rate increase application in Docket No. W-02355A-09-0275, Staff believes that the administration of these matters would most efficiently be handled if they were consolidated into a single proceeding.

WHEREFORE, Staff respectfully requests that Docket Nos. W-02355A-10-0330 and W-02355A-09-0275 be consolidated.
