PROCEDURAL ORDER

BY THE COMMISSION:

On September 4, 2009, Rick L. Stockett on behalf of CFT, Inc. ("CFT"), CPR Life Mask ("CPR") and Carefree Trading, Inc. ("CTI") (collectively "Complainants") filed with the Arizona Corporation Commission ("Commission") a Complaint which alleged that Complainants were being billed improperly by Qwest Corporation ("Qwest").

On September 28, 2009, Qwest filed its Answer and also filed a Motion for a Procedural Conference.

On October 5, 2009, by Procedural Order, a procedural conference was scheduled on October 28, 2009.

On October 28, 2009, Complainants, Qwest and the Commission's Utilities Division ("Staff") appeared for the procedural conference. The parties indicated that they would attempt to mediate their dispute with Staff.

On August 27, 2010, Complainants filed a Motion to Dismiss their Complaint indicating they had reached a satisfactory conclusion with Qwest.

Accordingly, the Complaint should be dismissed.

1 IT IS THEREFORE ORDERED that the Complaint filed by Rick Stockett, CFT, CPR and
2 CTI is hereby dismissed.

3 IT IS FURTHER ORDERED that Docket No. T-01051b-09-0425 is hereby closed.


