The original and 13 copies of this letter are submitted on behalf of TON Services, Inc. to request immediate cancellation of its Authority to provide Coin Operated Pay Telephone (COPT) service within the state of Arizona. A copy of the required Certificate of Convenience and Necessity Cancellation Form is attached.

The Company has ceased all regulated operations in Arizona as of July 1, 2010. TON Services, Inc. offered prepaid calling card services sold only at Flying J travel plazas, and had no presubscribed customers. Therefore, no customer notice was required.

Persons with outstanding card balances may contact customer service at (877) 664-5501 or (800) 359-9480 to obtain balance information and possible refunds. This information will be posted at Flying J travel plazas, the TON Services customer service department and the TON Services calling card website.


