PROCEDURAL ORDER

26 **BY THE COMMISSION:**

27 On June 22, 2001, the Securities Division ("Division") of the Arizona Corporation  
28 Commission ("Commission") filed a Motion to Extend the Deadline for Filing of Exceptions


1 ("Motion") with respect to the Recommended Opinion and Order of the Presiding Administrative  
2 Law Judge which was filed on June 13, 2001. The Recommended Opinion and Order was scheduled  
3 for the Commission's Open Meeting of June 26 and 27, 2001. Exceptions were due to be filed on  
4 June 23, 2001.

5 The Recommended Opinion and Order was removed from the agenda of the Commission's  
6 Open Meeting scheduled for June 26 and 27, 2001 and the Commission's next Open Meeting will be  
7 on July 24 and 25, 2001. In its Motion, the Division requests that the deadline for filing of  
8 exceptions be tolled until five days before the next Open Meeting of the Commission. The Division  
9 indicated that it intends to file exceptions, but requires an extension of time to address the effect of  
10 the Recommended Opinion and Order on the pending bankruptcy proceedings of Respondent James  
11 Douglas Sherriffs.

12 There have been no objections filed to the Division's Motion. Accordingly, the extension  
13 should be granted.

14 IT IS THEREFORE ORDERED that the date for filing exceptions to the Recommended  
15 Opinion and Order in the above-captioned proceeding shall be extended to July 20, 2001.


