PROCEDURAL ORDER

BY THE COMMISSION:

On December 29, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") in which it was alleged that Ms. Deborah Suann Angus committed multiple violations of the Arizona Securities Act.

On January 5, 2000, Ms. Angus filed a Request for Hearing and Motion for a pre-hearing conference.

On January 10, 2000, by Procedural Order, this proceeding was scheduled for a pre-hearing conference on January 20, 2000.

On January 20, 2000, the parties agreed to another pre-hearing being set on February 23, 2000. Subsequently, during a February 23, 2000 teleconference, counsel for the parties stipulated to the continuance of the February 24th proceeding pending settlement negotiations.

On June 23, 2000, the Division requested that a hearing be set and, by Procedural Order, a pre-hearing was set for July 17, 2000.

On July 17, 2000, a pre-hearing was held and it was agreed that a settlement would be concluded shortly.

On October 11, 2000, the Division again requested a hearing be scheduled because the parties were unable to conclude the settlement.

On October 23, 2000, during a teleconference, counsel for the Division and Ms. Angus agreed

1 to a hearing being scheduled on November 21, 2000.

2 On October 24, 2000, by Procedural Order, the hearing was set for November 21, 2000.

3 On November 15, 2000, the Division filed a Motion to Continue ("Motion") the proceeding
4 indefinitely because the Respondent had signed a Consent Order which is to be submitted to the
5 Commission for its approval at its next Open Meeting.

6 Accordingly, the Division's Motion should be granted.

7 IT IS THEREFORE ORDERED that the hearing on the above-captioned matter scheduled for
8 November 21, 2000, at 9:30 a.m., shall be continued indefinitely.


