

PROCEDURAL ORDER

11 **BY THE COMMISSION:**

12 On June 12, 2002, the Securities Division ("Division") of the Arizona Corporation
13 Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Brian
14 Bamman and Bamex International, LTD. (collectively "Respondents"), in which the Division alleged
15 multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of
16 securities in the form of commodity investment contracts.

18 The Respondents were duly served with copies of the Notice.

19 On June 24, 2002, a request for hearing was filed on behalf of all Respondents.

20 Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the
21 Notice and the presentation of evidence.

22 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on July 25, 2002
23 at 11:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


