PROCEDURAL ORDER

20 **BY THE COMMISSION:**

21 On August 14, 2001, the Securities Division ("Division") of the Arizona Corporation
22 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to
23 Cease and Desist, for Restitution, for Administrative Penalties, and for Other Affirmative Action
24 ("Notice") against Robert Dale Hylton; Hylton Enterprises, Inc.; Oreo Management Co.; Legend
25 Leasing Co.; Liberty Marketing Co.; and Passport Wholesale Supply (collectively the
26 "Respondents") in which the Division alleged that Respondents have engaged in acts, practices, and
27 transactions that constitute violations of the Arizona Securities Act ("Act").

1 On August 20, 2001 Respondents filed a request for a hearing and a pre-hearing conference.
2 Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the
3 Notice, the presentation of evidence and the scheduling of discovery timelines and a hearing.

4 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on September 17,
5 2001, at 9:30 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


