**PROCEDURAL ORDER**

**BY THE COMMISSION:**

On June 26, 2000, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") in which it was alleged that Mr. Jerome Alex Zanowski committed multiple violations of the Arizona Securities Act.

On July 5, 2000, Mr. Zanowski filed a Request for Hearing.

On July 11, 2000, by Procedural Order, a pre-hearing conference was scheduled on July 24, 2000 on the above-captioned matter. On July 24<sup>th</sup>, Mr. Zanowski did not appear and it appears that a copy of the Procedural Order may not have been received by Mr. Zanoswki since his name was not included on the service list.

On July 25, 2000, by Procedural Order, the pre-hearing conference was rescheduled for August 17, 2000.


On August 17, 2000, a pre-hearing conference was held with the Division and the Respondent in attendance. Subsequently, although the parties are attempting to negotiate a settlement, they requested that a hearing be scheduled. By Procedural Order, a hearing was scheduled for September 21, 2000.

On September 18, 2000, Mr. Zanowski filed a request for a continuance due to a serious heart problem that was verified by his treating physician. The Division has indicated that it does not oppose Mr. Zanowski's request.

1 Accordingly, the hearing should be rescheduled.

2 IT IS THEREFORE ORDERED that the hearing scheduled for September 21, 200 shall be  
3 continued to October 31, 2000, at 9:30 a.m., at the Commission's offices, 1200 West Washington  
4 Street, Phoenix, Arizona.


