PROCEDURAL ORDER

11 **BY THE COMMISSION:**

12 On October 3, 2001, the Securities Division ("Division") of the Arizona Corporation  
13 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to  
14 Cease and Desist and for Other Relief ("Notice") against Ms. Michelle L. Webb, dba Webb Financial  
15 Group, aka Michelle Webb Financial in which the Division alleged multiple violations of the Arizona  
16 Securities Act ("Act") in connection with the offer and sale of securities primarily in the form of  
17 Certificates of Deposit (CDs), viatical settlement contracts and other forms of investment contracts.

18 The Respondent was duly served with a copy of the Notice.

19 On October 29, 2001, Respondent Webb filed a request for hearing.

20 On October 30, 2001, by Procedural order, a pre-hearing conference was scheduled.


21 On November 13, 2001, a pre-hearing conference was held as scheduled. At that time,  
22 substitute counsel appeared on behalf of the Respondent. Counsel for the Division and the  
23 Respondent agreed that the pre-hearing should be continued until December 5, 2001, due to the  
24 replacement of Respondent's prior counsel.

25 On December 5, 2001, counsel for the parties filed a Stipulation to continue the pre-hearing  
26 conference from December 5, 2001 to December 20, 2001, and to schedule a hearing not earlier than  
27 60 days from the pre-hearing conference.

1 Accordingly, the pre-hearing conference should be continued, but until the pre-hearing  
2 conference is held, a hearing will not be scheduled.

3 IT IS THEREFORE ORDERED that the pre-hearing conference shall be continued to  
4 December 20, 2001 at 9:00 a.m., at the Commission's offices, 1200 West Washington Street,  
5 Phoenix, Arizona.


