PROCEDURAL ORDER

BY THE COMMISSION:

On September 7, 2000, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Global Harvest Corp. ("GHC") David Patten and Albert Tabah, (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts or commodity investment contracts. As a result of the T.O., the Respondents were immediately ordered to cease and desist from violating the Securities Act of Arizona.

The Respondents were all duly served with copies of the Notice.

On September 26, 2000, Respondents GHC, Mr. Patten and Mr. Tabah filed a request for hearing.

Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the T.O. and the Notice and the presentation of evidence.

IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on October 11, 2000, at 11:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


